The author(s) should mention any financial support of their publication, in particular, concerning funding of projects within which a particular research has been conducted. It is forbidden to publish the same papers in more than one journal. To avoid this, we strongly recommend author(s) to refrain from multiple, duplicate and/or concurrent publications or parallel or simultaneous submissions, see more in AJEE Authors Guide <http://ajee-journal.com/submissions> The exceptions of these rules are listed in the full version of PEMS AJEE, in particular, the duplicate submission for publication of a work, consisting part(s) or a whole text of a work, published previously, is allowed, only if this may facilitate an academic discussion, which was made with the permission and acknowledgement of the origin source.

All our author(s) should confirm their strong support and execute PEMS AJEE, which is reflected in signed by them Transfer of the Author's Rights Agreement.

Peer-review process. All of AJEE content is subjected to double blind peer-review with the aim of obtaining advice on individual manuscripts from reviewers and recommendation about publication of the article and/or improving the study. The only exception of peer review is an Introduction of the Editor-in-Chief, that appeared in each of the Journal's issues.

In general, reviewers are external experts, who are well-known specialists in a particular area of legal research, related to the manuscript, chosen by editors to provide written opinions and who have no conflict of interest or competing interest with the author(s). Reviewers inter alia should point out in their review the relevant published sources which have not been yet cited by author(s) of the manuscript, but are necessary for this study conduction. It is upon their best judgment to provide the written opinion in the review or to make it clear in the text of the article. All reviewed articles should be treated confidentially prior to their publication, the responsibility for this lies upon author(s), reviewers and editors jointly. All our reviewers confirm their strong support and execution of PEMS AJEE before a responsible editor.

Publication ethics. AJEE is proud of the high-quality content, selected and published by us. Due to this, we take reasonable steps to identify and prevent the publication of papers where research misconduct has occurred without any exceptions. Our Publishing Model, Article Processing Charges and Waivers

Authors pay a one-time Article Processing Charge (APC) to cover the costs of peer review administration and management, professional production of articles in PDF and other formats, and dissemination of published papers in various venues, in addition to other publishing functions. There are no charges for rejected articles, no submission charges, and no surcharges based on for the length of an article, figures or supplementary data. The only exception is the articles, written in collaborative authorship. In this case, the APC will include an additional payment for each of co-authors. Some items (Editorial Notes, Corrections, Retractions, Comments, Book Reviews, Conference Announcements etc.) are published free of charge.

AJEE waives 20% of its content every issue. We are committed to supporting the transition of all research to full open access, so offer APC waivers or discounts to some authors. We display an APC in order to demonstrate to authors that there is a cost to publication.

Members of **association** founded and affiliated to an AJEE journal benefit from a discount as well as authors affiliated to institutions participating in our **Partners Program**.

Waivers may be granted on a case-by-case basis upon request. Applications submitted before article submission are assessed by the Managing Editor based on the quality of the research article and the authors' ability to pay.

If the article is cited by other authors more than 10 times in the next two years after its publication in journals listed in the Web of Science Core Collection, the Editorial Board reserves the right to pay compensation to its author in the amount of payment for its publication.
